#### COMMITTEES

ByLAWS ARTICLE V - Board of Directors

<u>Section 14</u> - Committees. The Board of Directors may, from time to time, appoint committees as they deem necessary, providing always that:

- Such committees may include both voting and non-voting members of the Board and any regular member of WADA. Honorary members may not serve on committees.
  - (2) There shall exist a permanent standing committee on:
    - (A) Rules and Bylaws
    - (B) Tournaments/Activities
    - (C) Judiciary
    - (D) League Play

The Chairman of the Board shall appoint the Chairman of each committee. The Chairmen of the Rules and Bylaws and the Judiciary committees shall be appointed from among the voting members of the Board of Directors. The Chairman of each committee shall appoint, with the concurrence of the Board, the members of the committee. Any Director may at any time challenge the composition of any committee and demand a vote by the Board of Directors on a committee's membership.

# **ABSENTEEISM - Board Attendance**

ByLAWS ARTICLE V - Board of Directors

Section 8 - Absenteeism. A Board member is automatically expelled from the Board: (a) after three (3) unexcused absences from regular meetings during his/her term of office, or (b) after two (2) consecutive unexcused absences from regular meetings, or (c) after missing one-third (1/3) of the regular meetings within any consecutive 12-month period. An excused absence is when a Board member notifies the Chairman of the Board of Directors prior to the meeting of his/her inability to attend (for valid reasons, i.e. illness, work schedule, family emergency) and notifies the region's alternate of his/her responsibility to attend the meeting, or in the case of emergency, the board member notifies the Chairman as soon as is practical.

The Chairman of the Board of Directors has sole authority to grant an excused absence. A Board member expelled for absenteeism shall not be permitted to run for office for a period of three (3) years.
