**REPORTS**

1. Chair - Rob Bunnell.
  - a. Welcome new board member Ivan Jensen
  - b. Landon Jones leaving the area. Need new Board member.
  
2. Secretary/Treasurer - Pat Martin
  - a. Jan minutes were approved online by Rob, Vic & Joe.
  - b. Treasurer's reports to be provided soon. Still collecting delinquent Shooter fees.. Starting to collect Sponsor fees.
  - c. Website being updated as normal, no problems.
3. Executive Director - everything seems to be going all right.
  - a. The changes have been pretty well received with singles. Most players like it. No complaints and we've gotten back a couple players who weren't playing.
4. Tournament Director - Ronda Daly
  - a. Target Darts - Discussed potential collaboration with **TargetDarts** to provide tournament boards. Need to also discuss with Dart Guys.
    - i. Proposed a **Target-sponsored open singles event** to enhance sponsorship visibility and funding.
  - b. Need board members to secure sponsors. Aiming to secure \$3,500 in sponsorships to help cover tournament costs. Emphasis on acquiring more sponsors to improve tournament profitability and prestige.
  - c. Increased payout requirements set by **WDF** raised the expected payout to **\$23,260** this year.
  - d. Ordered folders to create sponsorship packages to include a tournament flyer and one of the tournament director business cards recently ordered. (Ordered cards for Timmy also.)
5. League Structure and Rules Review
  - a. Addressed concerns about competitive balance in the B League regarding A players on teams.
  - b. Proposed a review of **DartConnect** statistics to better understand team averages and player eligibility.
    - i. Aim to establish clearer rules regarding player classifications before the next season.
  - c. Reminder for board members to communicate with captains regarding rules and updates.
6. Other
